A loose animal in the car is dangerous because:



Increases driver distraction.



It can interfere with driving by climbing on top of the driver or by affecting the mechanical systems (pedals, gear lever, etc.).



It poses a risk to other road users, such as a dog with its head sticking out of the window, due to the risk of falling.



It can cause very serious and even fatal damage to the rest of the occupants in the event of braking or impact. In the event of a head-on collision at around 50 km/h, unrestrained pets multiply up to 15 times their own weight. That is, a 12 kg dog could weigh more than 180 kg.

HOW DO WE TEST FOR SAFETY?

We test our pet protection systems at dynamic testing facilities that feature cutting-edge equipment and technology. We benchmark the performance of our system against the latest United Nations ECE child restraint standard (R129).





FRONTAL IMPACT TESTING

WHAT DOES THE TESTING INCLUDE?

Using R129's velocity and performance criteria as a testing model, we perform simulated frontal and side-impact crash tests using advanced Q-series dummies.

WHAT HAPPENS DURING TESTING? During testing, these dummies are situated to simulate different postures and positions that your pet may take while riding in the pet protection system. These dummies remained contained within the protection system throughout this testing, helping to shield vehicle occupants and passing our modeled performance criteria.
